

Competition rules

ARTICLE 1: ORGANIZER

The organizer and manager of the personal data collection in the “Autoslagalica” game of skill is “Tokić Ltd.” (hereinafter: “Organizer”).

ARTICLE 2: DURATION AND PURPOSE OF THE TENDER

ARTICLE 5: RESULTS OF THE PRIZE COMPETITION AND COLLECTION OF PRIZES

Winners will be notified by email. If the Winner does not respond to the Organizer's invitation by e-mail within 5 days, the Organizer will once again notify the Winner by e-mail. In case of non-appearance of the Winner within 2 days from the re-notification of winning the prize (a total of 7 days from the announcement of the Winner and the first appearance to the Winner), it is considered that the Winner does not want to take the prize and Organizer can use prize in future contests or select another winner. The prize will be collected at any store of Tokić Ltd. which the Winner selects with prior notice to the Organizer. The deadline for collecting the prize is two weeks from the date of notifying the Winner that the prize is ready for collection. If the Winner does not pick up the prize within the prescribed period, the Organizer has the right to keep the prize, use it in future prize competitions or select another winner. - if the content created by the Participant violates the rights, patents or trademarks of third parties, the Organizer has the right to remove such content without explanation;
