**Conclusion of a Lease Agreement for a New Logistics and Distribution Centre**  
*(Regulated information)*

Further to the Announcement regarding the contemplated long-term lease of a logistics and distribution centre published on 29 April 2026 (<https://eho.zse.hr/obavijesti-izdavatelj/view/66462>), TOKIĆ d.d. (hereinafter: the Company) hereby announces that on 7 July 2026 the Company entered into an agreement with Logis Helena d.o.o. for the long-term lease of a new logistics and distribution centre located in the Sveta Helena Business Zone, Sveti Ivan Zelina. The lease agreement for a new highly automated logistics and distribution centre with a total area of around 40,000 m<sup>2</sup> has been concluded for a period of 15 years.

The Company has commenced preparations for the fit-out and equipping of the new logistics and distribution centre at the leased location and expects the facility to become operational during 2027. The Company will inform the investment public accordingly.
